#### Introduction:

The Public Health Forum promotes the value of public health nursing, ranging from travel health, immunisation, TB, sexual health, HIV, health protection and occupational health. It is essential to promote good health and protect against ill health for individuals, communities and across the population.

We believe that all nurses, midwives, health practitioners and students should utilise the principles of public health wherever they work. We work to raise awareness, respond to consultations, provide, and support educational events, publish competency frameworks and guidance and provide a range of resources on the RCN website.

In 2022 the forum has had a busy and productive year focussing on the recovery from the global pandemic of COVID-19. This had an unprecedented impact on forum members across the four countries.

During the year the steering committee had a full complement of members (seven) the committee members come from a range of public health areas to reflect a wide area of public health practice. One member left during the summer and two members came to the end of their term. Both places have been filled. One member has extended their term and the other will join the committee in January 2023.

The annual strategy planning meeting was held virtually on 18<sup>th</sup> February 2022. The aim is to have this in person next year in 2023. However, the catch-up meeting with the steering committee members will remain being held on Microsoft teams.

The forum also agreed to ensure all members of the committee have their profile on the forum webpage<sup>1</sup>. This is alongside an extended list of contacts from the wider public health forum. These colleagues have particular skills and expertise and their role and biographies are also represented on the forum page. They have supported the forum and the wider public health work of the RCN with; specific projects, alliance membership to various stakeholder groups and in helping to keep the various public health related clinical topic pages up to date. It will be revised next year to reflect new members.
