Corridor care: 'Devastating Testimony'

RCN General Secretary and Chief Executive Professor Nicola Ranger said: "This devastating testimony from frontline nursing staff shows patients are coming to harm every day, forced to endure unsafe treatment in corridors, toilets and even rooms usually reserved for families to visit deceased relatives. Vulnerable people are being stripped of their dignity and



nursing staff are being denied access to vital lifesaving equipment. We can now categorically say patients are dying in this situation."

Whenever you see concerning practices in the workplace, including corridor care, raise a concern in line with your employer's policy. Raising concerns isn't always easy, but it's the right thing to do.
